- Rupee traded very weak on back of dollar rise and sell off in primary capital market rupee dropped below 76.85. Rupee can be seen under pressure as the risk sentiment has increased in market hence safe heaven dollar buying is witnessed. Rupee has been taking resistance on 20dma on daily basis and looks very likely rupee can further witness fall towards 77.00 beyond on coming session.
- Gold prices witnessed volatile moves in the week, with prices going low at 50500 and rebounding back towards 51500 as well. In a mixed reaction on FED's policy update where the intention to raise rates were certain, but not to an extent of 0.75bps at a go. Hence markets cheered the move but again faltered broadly price remained volatile between the said range of 50500 and 51500 in the whole week.
