Broadly trend remains weak due to 20 year high dollar index prices above 109\$
- Gold prices witnessed fall as dollar index yet again claimed 20year high prices during the week, comex gold saw fall towards 1705\$ from 1750\$ last week where as MCX Gold witnessed decline from 51500 last week to below 50000 as fed's hawkish stance helped dollar scale higher and despite inflation high gold keeps weak trend continued.
