- On daily chart Nifty is forming Cup and Handle pattern on daily chart
- On daily chart index is trading above all its strong DMA's like 200-100-50 which shows strength of index.
- If we observe weekly chart, Nifty is trading in rising channel pattern and it has recently taken support from its lower band of the channel and rose sharply.
- If we look at volume part we witnessed a strong volume breakout on daily chart.
- If nifty closes above 10800 mark then we may see immediate bounce till 10930-11120.
- Overall targets of Cup and Handle pattern can be seen near 11500 zone.
- Strong support for Nifty is coming near 10550 zone and below 10400 mark said pattern will get nullify.
